- To provide support and facilities for community use and to maintain, improve and renew those facilities in particular for the advancement of citizenship and community development.
- The Board shall seek the views of the Community from time to time as it considers appropriate
- The Board will not discriminate on the basis of race, sex, disability, sexuality, age or on the basis of political, religious or other opinions.

Membership Qualifications

- Ordinary membership is open to any individual aged 16 or over who lives in the community, or members of the user group who supports the purposes of the organisation.
- Corporate membership is open to any business or organisation with a demonstrable interest in Kettins Parish and which supports the purposes of the organisation.
- Junior membership is open to any individual up to the age of 16 who supports the purposes of the organisation.
- Employees of the organisation are not eligible for membership.

Liability of Members

Members are not liable to contribute to the assets of the SCIO upon its winding up.
